## Ways to leave a legacy to St. Vincent de Paul

### ▶ ***A legacy gift through your Will or Trust***

Include the seminary in your WILL or LIVING TRUST with a gift or - a specific amount - a percentage - or a residual interest.

### **Bequest Language for Planned Giving to SVDP**

The following language should be used for making a gift to St. Vincent de Paul by will or revocable trust:

“I hereby give to the Regional Seminary of St. Vincent de Paul in Florida, Incorporated, not-for-profit Corporation, with its principal place of business at Boynton Beach, Florida.”

### ▶ ***Participation in a Life-Income Gift Arrangement***

Establish a CHARITABLE REMAINDER TRUST that pays you income for life.

### ▶ ***Name the seminary as beneficiary of a Retirement Plan (IRA) or LIFE INSURANCE POLICY***

Designate the seminary as a beneficiary of all or part of your IRA or other retirement plans, or designate the seminary as the beneficiary of an insurance policy.
